## AN ORDINANCE ELECTING TO FACILITATE REUTILIZATION OF NONPRODUCTIVE LAND

Ordinance No. 11- 02

WHEREAS, the Village of Magnetic Springs is located within Union County, State of Ohio; and

WHEREAS, the Village of Magnetic Springs, Ohio elects to facilitate the reutilization of nonproductive land within the Village; and

WHEREAS, the Village of Magnetic Springs, Ohio seeks to have the option to obtain existing nonproductive lands within the Village boundaries; and

WHEREAS, there does exist nonproductive lands within the boundaries that requires the implementation of a land reutilization program so that these lands can return to tax revenue generating status or can be devoted to public use; and

WHEREAS, the Village of Magnetic Springs, Ohio has the authority to enact said legislation pursuant to Ohio Revised Code Section 5722.02.

THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE Village of Magnetic Springs. Union County, Ohio, that

SECTION I: That Village of Magnetic Springs hereby elects to facilitate the reutilization of nonproductive land within it boundaries, pursuant to Ohio Revised Code Section 5722.02.

SECTION II: The Village of Magnetic Springs shall determine on a case by case basis its interest in those lands which become eligible for acquisition pursuant to Ohio Revised Code Section 5722.03, as to the appropriateness and availability for the Village to acquire the property under the reutilization program.

**SECTION III**: This Ordinance shall be in full force and effect at the earliest date allowed by law.
