OPENING:

This meeting of the Council of the Village of Magnetic Springs was called to order by Mayor "Kathy" Cantrell at 7:46 PM at 30 W. Magnetic St., Magnetic Springs, OH 43036.

MINUTES:

WARRANT LISTING:

Ritchie read the warrants. The total amount payable is \$3578.10. Mayor Cantrell requested payment of additional \$30.00 for Union County Health Department for the Food Vendor Permit for the Mini-Fest 2008. Ritchie was instructed to produce the warrant bringing the amount payable to \$3618.10. Pierce made a motion to accept the warrant listing as amended and pay the bills. Dean Bowsher, Sr. seconded the motion and all council members agreed.

OLD BUSINESS

Balling Property:

At June meeting Boggs advised we were permitted to assign one person to remove the raccoons. There was a call to the Health Department after our meeting from a Village resident. Council needs a motion for Village to approach RDI to permit removal. Boggs is working on resolution to pay to tear down the Balling property at 41 Rose St. The question would be if we could afford to move forward with the venture.

Boggs noted McClary advised the well would need to be removed prior to the removal of the property. The Health Department is going to assist with the removal of the building. Resolution is needed to remove the structure at 41 Rose St. ORC 17.26 states we can after notification to the property owner. We could eliminate the need for trapping if the building can be removed. A special meeting will be scheduled to vote on the resolution. Boggs will draft the resolution. We need to obtain something in writing that Buckeye Waste will take on the cost of removal. Bill McClary is the one that should be questioned with this. Boggs said meeting with McClary present was imminent. Special meeting to discuss Balling property at 41 Rose St will be set for July 30, 2008 at 7:30 PM. Ritchie will make notice for residents.

Carpet for Council Room:

Verity questioned Boggs if the Village could establish a line of credit with Home Depot to purchase carpet for the council room and make payments. Boggs does not see any issue with this establishment of credit. Verity expressed we would need approximately \$700.00. Boggs will check to ensure that there is no reason why this can be done.
