The meeting was called to order at 7:00 PM by Mayor Baughman.

Legal Business:

It was noted that a letter was sent by Alison Boggs to the owner of Lee Dog's Saloon & Grill concerning the Adult Oriented Business Ordinance. Information concerning the ordinance for the gazebo was presented. Discussions were held concerning Emergency Squad Contract with Richwood. Question was posed as to whether the village would have Emergency Squad coverage if the contract with Richwood was not present. It was noted that Marysville had refused to give us service and that was the reason behind our contract with Richwood Fire Dept. Alison Boggs will Review information to see if we do indeed need the contract with the Richwood Fire Dept. Alison Boggs exited.
