OPENING:

This regular meeting of the Council of the Village of Magnetic Springs was called to order by Mayor Martha "Kathy" Cantrell at 7:03 p.m. at 30 W. Magnetic St., Magnetic Springs, OH 43036.

VISITORS—Regarding the property on Fountain Ave. that has sold-septic did not pass inspection, and is being replaced. Liz Terry, new owner is requesting permission to tap into existing tile from Village. Members had no objection to this. Tuck will write up the easement. Chad Wilson informed council that he is all set on his housing project and thanked the village for their efforts.

SOLICITOR—no reports.

TREASURER REPORT/WARRANTS/BUDGET:

The bank reconciliation report was not completed for the month of September.
