Council Meeting Minutes
November 10, 1994

Council Members Present: Charlene Conrad, Rex Baldwin, Rex Clevenger, Bill McCarty, Bob Baughman, Rex Pierce and Shirl Stultz
Others Present: Bob Parrott, Jeffery Brandt (Ohio Edison) Barry Drumm, Lorrie Pheifer, Harvey Hecker and Marty Levering.

Mayor called meeting to order. Clerk read minutes from October meeting, Bill made motion to approve minutes as read, 2nd by Bob Role Call vote, all yeas. Treasurers report was given and bills were presented for payment, Rex B. made motion to approve Treasurer's report as read and approve bills for payment, 2nd by Bill. Role call vote, all yeas.

Jeff Brandt from Ohio Edison introduced himself and talked about his duties in conjunction with the Village.

Report was given on the unlicensed cars, camper on May street has been moved.

Sewer Committee-Marty talked about problem on Magnetic St, Rex C said the alley behind Harvey's still needs a clean out plate ~~needs~~ to be put in at the outlet. The clean out at the corner of alley & May street is in need of repairs. Rex suggested it be moved before trouble starts. No action was taken.

Street Committee: snow plow has been put on in preparation of the first snow fall. Rex P & Bill reported that the angle is not working properly & needs to be checked out. New tires are needed, Bill will contact Dotson's to have them replace tires & check on plow. Street signs, Steve Stolte can purchase & replace no parking & alley signs that we need at cost. Cross walks still need to be done, ODOT says it is not in their contract. Marty offered his small striping machine for this, Mayor will talk with Wilbur Cantrell to get needed paint. Street Committee needs to check signs and let Mayor know at next meeting.

Issue 2 is still looking good, the application has moved up one more step. Bids should be coming in for sidewalks, so hopefully we will be ready in the spring to begin. Poggemeyer wants the Village to complete a 10 year recommendation of things we want to complete. 1995 - sidewalks & storm sewers, 1996 - firehouse repairs, 1997 - storm sewer replacement, 1998 - road resurfacing phase I, 1999 - road resurfacing phase II, 2000 - sanitary sewer compliance, 2001 - sidewalks on secondary streets, 2002 - fire wells, 2003 - clean up of creek, 2004 - park restoration.


Warner Cable notified the Village that the rates are to go up \$.37 per year.
