VILLAGE OF MAGNETIC SPRINGS COUNCIL MEETING MINUTES FOR NOVEMBER 13,1997

Council members present were: Bob Baughman, Bill McCarty, Rex Pierce, Rex Carol Verity, Kathy Cantrell, and Clerk Lorrie Pheifer. Others in attendance were: Janis Davis, and Allen Fitzpatrick. The minutes of the Oct. 9th,1997 meeting were read with McCarty making a motion to approve the minutes as read and Pierce seconding the motion. All yeas. The treasurer's report was given with a balance of \$ 57,010.84 total of all village accounts. McCarty made a motion to accept the treasurer's report as read and pay all bills with Pierce seconding the motion. All yeas.

Bob Baughman stated that he felt the storm sewer project down May Street was going very well. Clevenger stated that the brush that was accumulating by the Fuller property on Millard Street has been cleaned up. Council voiced some concern over the old storm sewer drains being plugged up by the new sewer lines so as water could not visibly be seen running beneath. Acting Mayor Verity stated she would check into this problem. Rex Pierce stated that his sidewalk by Park Street had been torn up from this project. Verity stated this would also be looked into. The Fire Chief had no report at this time. Mc Carty stated he felt that Trick or Treat night in the village went very well. McCarty and Pierce supplied the treats, 120 donuts and 5 gallions of cider, for the village at the Fire House. McCarty stated residents had noted that the shortened time slot worked very well. Verity asked council about signing the E.M.S. Contract with the City of Marysville. This would be to service the Village of Magnetic Springs for the years beginning 1998 and ending 2001 for \$2100.00 per year. McCarty made a motion to approve the contract with Baughman seconding the motion. All yeas. Verity also asked council for approval to make a final disbursement on the Phase II sewer project by ODPW. McCarty made a motion that the disbursement be made with Baughman seconding the motion. All Yeas. Council noted that the Barkhurst property has yet to be secured as determined in the contract between Barkhurst and the village. Verity stated she would check on this to find out who should be looking into this problem. Clevenger asked that a flyer be circulated pertaining to trash pickup in the village. Pheifer will get these to Clevenger to pass around. Notification was sent to Earl Price concerning the stay on the demolition of the Backhurst block building property.

In new business Verity asked Council if they would like to sign a contract with the Union County Chamber of Commerce for Economic Development. Council showed no interest in doing so for the 1998 year. Verity informed council that the Operating levy had failed and wanted to know if council wanted to put it on the primary election ballot for 1998. McCarty stated perhaps giving the village residents a break if the money generated is not specifically needed for that time frame. Council agreed. Verity relayed to council that the CDBG sidewalk project to go down May Street has been awarded to S.E. Park Enterprise Inc. Of Marion. Verity asked council if an ordinance was needed concerning the parking of Semi trucks along the Main Street of the village. McCarty stated that since the Main

Street is also a state highway the village has no control.	However, if a traffic
problem exists the sheriff should be called.	
McCarty made a motion to adjourn the m	esting with Pierce se
