

**VILLAGE OF MAGNETIC SPRINGS  
COUNCIL MEETING MINUTES FOR Oct. 21, 1999**

Council members present were: Bob Baughman, Kathy Cantrell, Melissa Stiles, Rex Pierce, Ben Laird, Carol Verity, Mayor Bill McCarty and Clerk Lorrie Pheifer. Others in attendance were Janis Davis, Jim Cox, Anne Davies, and Alan Fitzpatrick. Mayor McCarty brought the meeting to order with the reading of the Sept. 16th minutes. Pierce made a motion to accept the minutes as read with Laird seconding the motion. All yeas. The treasurers report was given with a balance of \$67,992.98 total in all village accounts. Verity made a motion to approve the treasurers report and pay all bills with Cantrell seconding the motion. All yeas.

Mayor McCarty asked for Committee Reports. The gravel has been added to the alley between the Teets' and Sloan properties. Pierce stated all the trees overlapping the sidewalks along the Main Street have been trimmed.

The Mayor introduced Anne Davies of the Union County Health Department. Ms. Davies spoke on the upcoming levy and hopes for the passage of such. Ms. Davies spoke of responsibilities of the Health Department and their commitments to the County as well as the individual villages.

In Old Business Verity asked about the flags for the village. New Flags are needed for the season as well as poles and brackets to be replaced. Verity stated she would check on prices and report on these next meeting. McCarty stated they would need to be gotten soon so they could be put up for the holidays. The posts to be replaced at the gazebo will be done soon. Laird suggested possibly getting posts from the Engineer's department. Laird will check on this. The Mayor gave a reminder on Trick or Treat night and Clean-Up day.

In New Business Jim Cox asked permission of the council to construct a sectional home on DeGood Street beside the Manville residence and his cottage. In doing this he would need to obtain an easement for sewage lines from Park Street to run to his home. Laird stated he didn't see a problem, but would like to look at the work being done. Cantrell made a motion to approve Ordinance # 99-08 to allow Cox the easement with Laird seconding the motion. All yeas. The ordinance states within that all property disturbed by this would be put back as was before. Pheifer told council of new costs being billed for squad runs by other townships within the county. Current charges are \$100.00 for basic run, \$150.00 for medical assisted runs. New charges would be doubled. Pheifer suggested staying within the guidelines of the township so fees wouldn't be different from neighbor to neighbor. McCarty stated he would go to the Nov. 1 township meeting to discuss this proposal and report back next meeting.

Verity reported on the Union County Trustees meeting in New Dover she attended on Sept. 16th. Verity stated that a new Zoning inspector had been introduced, Greg Harris. Harris hopes for Countywide Zoning regulations. Verity also stated that the grants for community improvement will be awarded Nov. 4 at the Dover Township hall. Magnetic has signed with Leesburg Township for a grant for a shelterhouse at the Ballpark.

Cantrell made a motion to adjourn the meeting with Laird seconding the motion. All yeas. The next meeting will be ~~October~~ <sup>Nov. 18</sup> 21, 1999 at 7:00 p.m. at the Fire House.
