OPENING:

This organizational meeting of the Council of the Village of Magnetic Springs was called to order by Mayor Chad Wilson at 7:00 p.m. at 30 W. Magnetic St., Magnetic Springs, OH 43036.

SHERIFF— Deputy took down contact information for council members.

HOUSEKEEPING:

2024 Fiscal Year End—Tuck filed 2024 FYE reports and Hinkle.

Council President—Lutz nominates Marynelle Liston for president. Liston will be notified at the next meeting, as she is not present tonight. Pierce seconded the motion and all present council members agreed.

Schedule—council voted to keep the schedule the same; council will continue to meet on the third Thursday of each month at 7:00 at the community center. Lutz made the motion to keep the schedule the same, Wheeler seconded the motion and all present members agreed.

Contact Information—Tuck asked if any contact info needs updated for the council list. Lutz requested her home phone number be removed and replaced with her cell phone.

MINUTES:

December 2024 minutes were not presented to Council.

TREASURER REPORT/WARRANTS/BUDGET:

Casey Tuck presented council members with the warrants payable for Ohio Edison, Columbia Gas, Time Warner Cable, etc. The total amount due for all warrants as payable was \$3422.91. The bank reconciliation report for December was presented and balanced. Wheeler made a motion to accept and pay the warrants, Pierce seconded the motion, and all present council members agreed.

OLD BUSINESS:

CDBG Grant— Thomas Perry was present to discuss the CDC grant. He would like any pictures of failed septic systems, support letters, etc. Perry says he is still waiting on reports from the UCHD to supplement the grant. Langoehr says he will contact an owner he is aware of that has septic issues to see if they will

document their experience. Perry added that any reports on how the creek has been affected are welcome. Wheeler says that at Rose Street where the basin storm sewer is located, has a septic smell occasionally. Perry asked Wheeler to document that as well. Mayor Wilson questioned how the threshold was; Perry says we are meeting the minimum but he really wants to stand out and send the grant.

Delinquent Taxes—no updates.

Magnetic Springs Website—Mayor Wilson asked if council wants the website up for an additional year; all agreed yes. Tuck asked Wilson to send her the invoice for the cost of the website.
