# TREASURER REPORT/WARRANTS/BUDGET:

Land Bank for a period of time in order for the delinquent taxes to be forgiven. The land will be deeded back, tax free, with the promise of using for village purposes, such as community gardens, etc. There will also be a grant available in spring of 2025.
