- Zoning status report
  - 103 W. Park
    - demolished 12/14/24 via Fannie Mae.
    - UCHD was emailed to ask about the existing septic system. They will handle the verification and enforcement.
    - Potential buyers have asked to put an RV on the property and live there on weekends.
      Per Ordinance 21.03.10 the request was denied via their realtor
    - Fannie Mae requires occupancy purchases only during first 30 days (or "certain governmental entities")
  - Need contact information for Elmer Fuller re: Vacant Property fees (\$2,000)
